Otherwise, the Policyholder shall undertake to provide documents supporting the position, name and address of the employer / degree of relationship / status (spouse).
- confirm that he/she has no registration, place of residence / stay, bank account in a state (territory) that does not comply with the FATF recommendations.
- · confirm that he/she is not limited in legal capacity, and actions on other grounds is not controlled by another individual (beneficial owner).
- confirm reliability of the above information and shall inform the Insurer in writing about changes made to any information specified in this Policy within 7 (seven) business days. The information provided by the Policyholder at the date of this Contract shall be considered up-to-date until the Insurer receives information about updates.
- give consent to the Insurer to the processing of personal data of individuals specified in this Policy and other documents transferred to the Insurer to deliver obligations under this Policy, for promotion of goods, works, services on the market through direct contacts to be made by the Insurer using communication facilities. This consent shall be valid for 5 (five) years from the date of expiration of the Policy or until withdrawal of the consent presented in the Insurer's office in accordance with requirements of Federal Law No. 152 of July 27, 2006 "On Personal Data".
- confirm that he/she has received the Insurance Terms and Conditions, their provisions have been explained and understood. Additionally, the Terms and Conditions of insurance can be found on the official website of the Insurer
- confirm that received a full information provided for in paragraph 2.1.2. of the Basic standard for protection rights and interests of individuals and legal entities recipients of financial services provided by members of self-regulatory organizations incorporating insurance organizations approved by resolution of FSC of Central Bank of the Russian Federation, Minutes of 08/09/18 No. KFNP-24.
- agree to interact with the Insurer contacting offices of the Insurer, communicate by post and telephone and other facilities in cases specially provided for in the Insurance Terms and Conditions.
- · agree to receive messages and notifications from the Insurer, including electronic format at the addresses, telephone numbers specified in this Policy.

Special details

The Policyholder shall be responsible for completeness and accuracy of the information specified in this Policy. Form, procedure and insurance indemnity payment terms, list of documents to be provided and actions to be taken to be indemnified are provided for in clauses 2.26, 2.27, 2.28, sections 3, 4, 5 of the Insurance Terms and Conditions. The insurance contract shall not cover (shall not be recognized as valid claim) events caused by emergency circumstances (epidemics / pandemic), if the Insured failed to follow recommendations of government bodies, preventive quarantine actions. 
